### **LEPC Email Meeting Notes**

**Wednesday, May 27, 2020**

#### **COVID-19 Response and Recovery**

- Emergency Operations Center (EOC) has been activated virtually since March 11, 2020
- Emergency management has been assisting the Barry-Eaton District Health Department's (BEDHD) operational architecture and with Personal Protective Equipment (PPE) acquisition, inventory, and distribution to hospitals, first responders, long-term care facilities, adult foster care facilities, funeral homes, and other industry
- Emergency management opened a centralized single point of distribution for PPE throughout Eaton County on March 24, 2020
- Around 250,000 pieces of PPE distributed and 29 EOC Situational Reports distributed.
- Demobilization of distribution node is going to take place on Friday, March 29, 2020 at 4 pm. All remaining PPE will be re-inventoried and stored in the event of a resurgence of COVID-19
- The EOC will be transitioning to a Recovery Center
- After Action Report/Improvement Plan (AAR/IP) being drafted and must be submitted by September 30, 2020. The EOC is working on feedback forms to stakeholders regarding various aspects of the response. BEDHDs AAR/IP will be separate due to ongoing response for foreseeable future.

#### **Resources Update**

##### **Online Tier II Manager Subscription**

We are now subscribers to Online Tier II Manager through Michigan's Department of Environment, Great Lakes, and Energy (EGLE). Online Tier II Manager is how all facilities that are required to report hazardous chemical storage and inventory under the Superfund Amendments and Reauthorization Act (SARA Title III) submit their annual or

updated reports. This creates one repository for us to keep track of the chemicals in those facilities and minimizes receiving multiple paper copies of reports on an annual basis.

The Delta Township Fire Department, Grand Ledge Area Emergency Services Authority, and Windsor Township Emergency Services have subscribed as system users (+1 since last meeting).
