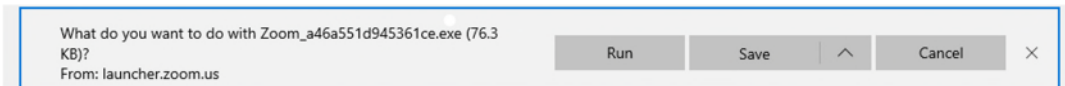

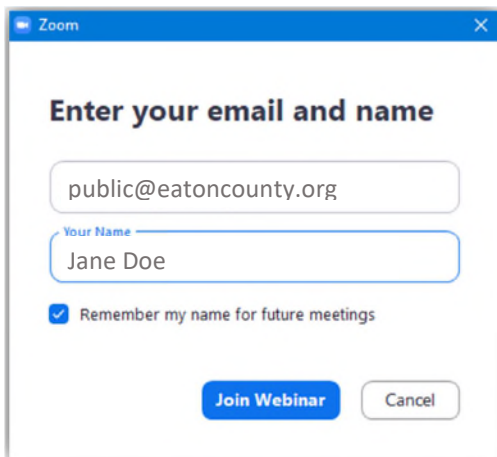
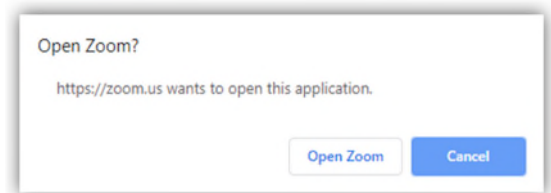

#### Participate By Using Zoom App

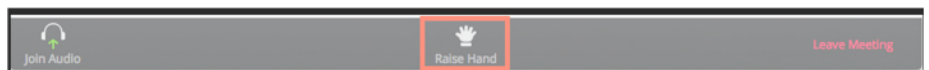
1. Go to the following link to join the meeting: <https://us02web.zoom.us/j/85491854699>  
This link will also be available on the meeting agenda posted on the Eaton County website.
2. Installing the program  
On an Pad, iPhone or Android device:  
You will be prompted to download the Zoom App. Download and install the app.  
On a PC:  
an .exe file such as "Zoom\_e170a223d08eff74.exe" will download. Click on the .exe file and follow the prompts to install. You may have to allow the program to run.



3. If you already have zoom installed, click Open Zoom  
(If prompted Meeting ID **854 9185 4699**)



4. Fill in your email and name.

5. Click Join Webinar
6. If you wish to speak during the public comment section please select the Raise Hand option. The host will unmute and allow your comment.
