EATON COUNTY BOARD OF COMMISSIONERS JANUARY 18, 2006

The Eaton County Board of Commissioners met in recessed session at the County Facilities, in the City of Charlotte, Wednesday, January 18, 2006.

Chairman Peters called the meeting to order at 9:00 AM.

The Pledge of Allegiance to the Flag was given by all.

Invocation was given by Commissioner MacDowell.

Roll call. Chairman Peters removed public hearing from the agenda.

Commissioner Johnson added 3 resolutions under Finance Committee:

The agenda stood as amended.

Commissioner Kempf moved the minutes of December 1 and 21, 2005 be approved as presented. Seconded by Commissioner MacDowell. Carried.

There were no communications.

Chairman Peters welcomed newly appointed Commissioner Sue Butler who will be representing District 10. He also announced there would be no Special Primary on February 28th, just the Special General on May 2, 2006.

Public Comment.

Chuck High, 7410 Delta River Dr., spoke about problems with the Lora Drain, which is an Intercounty Drainage District in Eaton and Clinton Counties. The cost of the improvements has increased greatly since the project first began.

Commissioner Brehler arrived.

Chairman Peters explained to Mr. High that the County has no jurisdiction over the Drain Commissioner, but he will refer the matter to the Public Works and Planning Committee.

Bill Woodard, 7354 & 7360 Delta River Dr. spoke about excessive charges with the Lora Drain and the fact he was not notified of the increase in cost.

Marilyn Schenk, 7200 Delta River Dr., agreed with the previous speakers and asked the Board to look into the situation.

New Business. Mona Ellard, Director of Eaton County MSU Extension introduced Jackelyn Martin, the new 4-H Youth Development Educator.

Commissioner Smuts moved to approve the appointment of Jackelyn Martin as the new 4-H Youth Development Educator for Eaton County. Seconded by Commissioner Forell. Carried.

Controller Fuentes distributed a handout regarding Group Life Insurance for the Board of Commissioners. All Board members must agree to participate in the program. Chairman Peters asked for a show of hands to determine if all of the members present were interested. It did not appear at this time that all were willing to participate. (Copy on file)

Chairman Peters asked Drain Commissioner Brady Harrington to speak about the concerns addressed earlier regarding the Lora Drain.

Drain Commissioner Harrington explained the cost for the easements for the project were more than anticipated mainly due to a court decision to split the difference in the appraised cost of the easements. He explained this is an ongoing problem with drain projects, because these projects are more frequently taken to court, which results in higher costs due in part to legal fees.

Chairman Peters reminded the Board of the Jail Expansion Workshop scheduled for Tuesday, January 31, 2006 at 9:30 AM in the Board of Commissioners room. Per Diem will be paid to those attending the workshop.
