## EATON COUNTY BOARD OF COMMISSIONERS December 20, 2006

The Eaton County Board of Commissioners met in regular session at the County Facilities, in the City of Charlotte, Wednesday, December 20, 2006.

Chairman Peters called the meeting to order at 9:00 AM.
