

EATON COUNTY BOARD OF COMMISSIONERS
MAY 16, 2018

The Eaton County Board of Commissioners met in regular session at the County Facilities, in the City of Charlotte, Wednesday, May 16, 2018.

Chairman Mulder called the meeting to order at 7:00 p.m.

The Pledge of Allegiance to the Flag was given by all.

Chairman Mulder gave the invocation.

Roll call. Commissioners present: Blake Mulder, Terrance Augustine, Howard T. Spence, Jeanne Pearl-Wright, Jane M. Whitacre, Joseph Brehler, Brian Droscha, Roger Eakin, Wayne Ridge, Brian Lautzenheiser, Kent Austin, Heather Wood and Barbara Rogers.

Commissioners absent: Christine Barnes, Glenn Freeman.

Commissioner Eakin Requested the following addition to the Ways & Means Committee report: item #4 Resolution Appointing the Eaton County Emergency Services Coordinator, and under New Business: International Union of Operating Engineers Local 324 Collective Bargaining Settlement Agreement.

Commissioner Lautzenheiser moved the agenda be approved as amended. Seconded by Commissioner Droscha. Carried.

Commissioner Lautzenheiser moved the minutes of April 18, 2018 be approved as presented. Seconded by Commissioner Rogers. Carried.

Communications:

Email received from resident Kathy Brown regarding annual flooding on Canal Road.

Letter from James Green, 10783 Hartel Road, regarding zoning for large solar arrays.

It was reported that the standing committees received the annual reports of the Drain Commissioner, Central Dispatch and District Health Department.

Public Comment:

Lynn Ball of Grand Ledge Homebuilders Association and Arrowhead Homes, and Jeff Teachout of Teachout Builders spoke regarding issues with concerns dealing with the Construction Code Department.

Sgt. Kuhlman, Emergency Manager, spoke regarding his position. He introduced Lt. Rich Martin Emergency Services Manager for MSP, and indicated he would be available to answer any questions the members have.

Commissioner Austin moved the approval of #18-5-47 Resolution Authorizing the State Disaster Contingency Fund Grant.

WHEREAS, Eaton County, Michigan, is a political subdivision within the State of Michigan with an official emergency operations plan in compliance with Section 19 of the Emergency Management Act, 1976 PA 390, MCL 30.419, as amended; and

WHEREAS, Eaton County sustained severe losses of major proportions brought on by the flooding resulting in the following conditions: road and culvert collapses; and

WHEREAS, the Eaton County Board of Commissioners certifies that the Eaton County Emergency Operations Plan was implemented at the onset of the disaster on February 19, 2018 and all applicable disaster relief forces identified therein were exhausted; and

WHEREAS, as a direct result of the disaster, public damage and expenditures were extraordinary and place an unreasonably great financial burden on Eaton County, totaling \$88,780.

NOW, THEREFORE BE IT RESOLVED, that Eaton County requests the Governor authorize a grant to Eaton County from the State Disaster Contingency Fund pursuant to Section 19 of the Emergency Management Act, 1976 PA 390, MCL 30.419, as amended.

BE IT FURTHER RESOLVED, John Fuentes, Controller/Administrator is authorized to execute for and in behalf of Eaton County the application for financial assistance and to provide to the State any information required for that purpose.

Seconded by Commissioner Rogers. Carried.

Commissioner Austin moved the approval of #18-5-48 Resolution to Recognize National Police Week.

WHEREAS, there are more than 900,000 law enforcement officers serving in communities across the United States, including the dedicated members of the Eaton County Sheriff's Office; and

WHEREAS, there have been 58,627 assaults against law enforcement officers in 2016, resulting in approximately 16,677 injuries; and

WHEREAS, since the first recorded death in 1791, more than 20,000 law enforcement officers in the United States have made the ultimate sacrifice and been killed in the line of duty, including three members of the Eaton County Sheriff's Office;

WHEREAS, the names of these dedicated public servants are engraved on the walls of the National Law Enforcement Officers Memorial in Washington, D.C.; and

WHEREAS, 360 new names of fallen heroes are being added to the National Law Enforcement Officers Memorial this spring, including 129 officers killed in 2017 and 231 officers killed in previous years; and

WHEREAS, the service and sacrifice of all officers killed in the line of duty will be honored during the National Law Enforcement Officers Memorial Fund's 30th Annual Candlelight Vigil, on the evening of May 13, 2018; and

WHEREAS, the Candlelight Vigil is part of National Police Week, which takes place this year on May 13-19; and

WHEREAS, May 15 is designated as Peace Officers Memorial Day, in honor of all fallen officers and their families and U.S. flags should be flown at half-staff.

NOW, THEREFORE, BE IT RESOLVED the Board of Commissioners formally designates May 13-19, 2018, as Police Week in Eaton County, and publicly salutes the service of law enforcement officers in our community and in communities across the nation.
