The Eaton County Drain Commissioner will hold a Day of Review of Drainage District Boundaries and Review of Apportionments on the above date, time, and location.

The Day of Review is an opportunity to review the tentative apportionments of benefit for each parcel and municipality within the Drainage District. A map of the proposed Drainage District boundary revisions can be found attached and on the Drain Commissioner's website at: www.eatoncounty.org/departments/drain-commissioner.

A general description of the lands by section number proposed to be added or deleted from the Drainage District as recommended by a licensed professional engineer or surveyor for each of the Drains is as follows:

The Drain Commissioner, engineers and/or other staff members will be available to assist individuals throughout the day and make revisions where necessary. There is no need to schedule an appointment for a specific time on the Day of Review. The computation of costs for the Drain will also be available at the Day of Review. Drain assessments are collected in the same manner as property taxes and will appear on your winter tax bill. If drain assessments are being collected for more than one (1) year, you may pay the assessment in full with any interest to date at any time and avoid further interest charges.

Persons with disabilities needing accommodations for effective participation in the Day of Review should contact the Drain Commissioner's Office at the number noted above (voice) or through the Michigan Relay Center at 7-1-1 (TDD) at least 24 hours in advance of the Day of Review to request mobility, visual, hearing or other assistance.

Comments on the drainage district boundaries or apportionment of benefits may be submitted to the Drain Commissioner in writing before the date of the day of review to the Eaton County Drain Commissioner at 1045 Independence Blvd., Charlotte, MI 48813 or Drain@eatoncounty.org, or comments may be submitted in writing or verbally at the day of review. Comments submitted in advance must be received by the Drain Commissioner prior to the day of review to ensure consideration.

You may appeal the Drain Commissioner's decision to revise the district boundary to the Eaton County Circuit Court within ten (10) days, and you may also appeal the determination of apportionments to the Eaton County Probate Court within ten (10) days.

The following is a list of any county, township, city, village to be assessed at large: Eaton County and Walton Township.

- A description of the lands constituting the drainage district.
- Number and length of sections, the average width of each section, and if the drain will be closed, the amount and specifications of all tile or pipe required;
- Location, number, type, and size of culverts or bridges to be installed, if any; and
- Conditions upon which the contract will be awarded.
